## **Admission Procedure for filling up N.R.I Seats of B.Pharm.**

The student who has passed examination from outside India would be exempted from GUJCET/ NEET- 2026 examination. Based on marks obtained in the qualifying examination he/ she would be included in the NRI Inter-se-merit list. Such candidates must fulfill the eligibility criteria prescribed by the State Government for admission. However, if the students have passed qualifying examination from India, they should have appeared in GUJCET-2026/ NEET- 2026 to be considered eligible for admission.

The students who passed qualifying examination from outside India shall have to obtain equivalency certificate from Association of Indian Universities, Delhi.

N.R.I. students who seek admission on N.R.I seat will have to submit copy of his/ her passport as well as passport of his/ her mother and/ or father, to prove himself/ herself as an N.R.I candidate. N.R.I sponsored students have to submit proof of his sponsor being an affidavit has to submitted. The relation of N.R.I (Sponsored) with the student (N.R.I sponsored candidate), sponsorer's undertaking the responsibility for payment of tuition and other fees as well as the entire responsibility of the candidate's study should be clearly mentioned in the affidavit.

Priority would be given to N.R.I candidates for admission on N.R.I seats.

N.R.I sponsored students shall be included in the merit list of N.R.I seats as well as in the merit list of Management Seats.

### **LIST OF DOCUMENTS REQUIRED:**

1. Copy of 12th standard Mark-sheet/ Grade Card.
2. GUJCET-2026 / NEET-2026 Score Card for Sponsored Candidates.
3. Copy of passport of admitted student and copy of passport of his/her mother and/or father proving NRI status.
3. Certificate of equivalence from Association of Indian University, Delhi, if NRI candidate passed qualified exam from other countries.
4. Affidavit of father/mother of NRI candidate undertaking responsibilities of tuition fee, other fees and other responsibilities till completion of course.
